SPECIAL CALLED MEETING ASHLAND CITY COUNCIL FEBRUARY 16, 2017

The Ashland City Council met for a Special Called Meeting on Thursday, February 16, 2017 at 5 P.M. in the Ashland City Hall auditorium to act as a disciplinary board and conduct a disciplinary hearing for Police Department personnel, with Mayor Larry J. Fetner presiding. Council Members present were Kim M. Cain, Annette F. Gaither, and Tommy Cantrell.
