## ORDINANCE NO. 2020-10-19-01

AN ORDINANCE TO AMEND ORDINANCE NO. 2007-10-15-01 OF THE CITY OF ASHLAND, THE "PERSONNEL POLICIES AND PROCEDURES", BY DELETING CERTAIN PORTIONS THEREOF AND ADDING CERTAIN REQUIREMENTS RELATED TO RELATIVES IN THE LOCAL GOVERNMENT SERVICES.

WHEREAS, the City of Ashland adopted its Personnel Policies and Procedures by Ordinance No. 2007-10-15-01, as amended, setting forth the rules and regulations to be followed in working with its employees; and

**WHEREAS**, the City has determined that it is now in the best interest of its employees to provide certain additional policies relating to relatives in the local government services.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ASHLAND, ALABAMA AS FOLLOWS:

**SECTION I.** The following portion of Personnel Policies and Procedures for the City of Ashland shall be amended as follows:

Paragraph K of section III, Relatives in the Local Government Services, is "DELETED" in its entirety and replaced with the following:

"Two or more members of an immediate family may not be employed under the same supervisor within the City service, if such employment will result in an employee supervising or being supervised by any member of his or her immediate family. This policy applies to new appointments, promotions, transfers, demotions, or reinstatements. A relative is defined as an individual who is related to another individual such as father, mother, son, daughter, brother, sister, grandchild, uncle, aunt, nephew, niece, husband, wife, father-in-law, mother-in-law, daughter-in-law, son-in-law, sister-in-law, brother-in-law, stepfather, stepmother, stepson, stepdaughter, stepbrother, stepsister, half brother or half sister, grandparent or step grandparent. When popular and legal usages differ, the strict legal definition will be applied."

SECTION II. All portions of the Personnel Policies and Procedures for the City of

Ashland not otherwise amended as set forth herein, shall remain in full force and effect.

SECTION III. Where necessary, the Personnel Policies and Procedures manual shall be

modified to reflect the page and paragraph identifications to comply with the above changes.

SECTION IV. This Ordinance shall be published by posting copies thereof in three

places within the municipality, one of which shall be at the Mayor's office. Said Ordinance shall take

effect five (5) days after said posting.

**SECTION V.** All Ordinances or parts of Ordinances which conflict with this Ordinance

are hereby repealed.

SECTION VI: All sections of this Ordinance are hereby declared to be severable; and if

any word, phrase, clause, sentence, paragraph or section of this Ordinance shall be declared

unconstitutional or invalid by the judgment or decree of any Court of competent jurisdiction, such

unconstitutionality or invalidity shall not affect any of the remaining words, phrases, clauses, sentences,

paragraphs and sections of this Ordinance.
